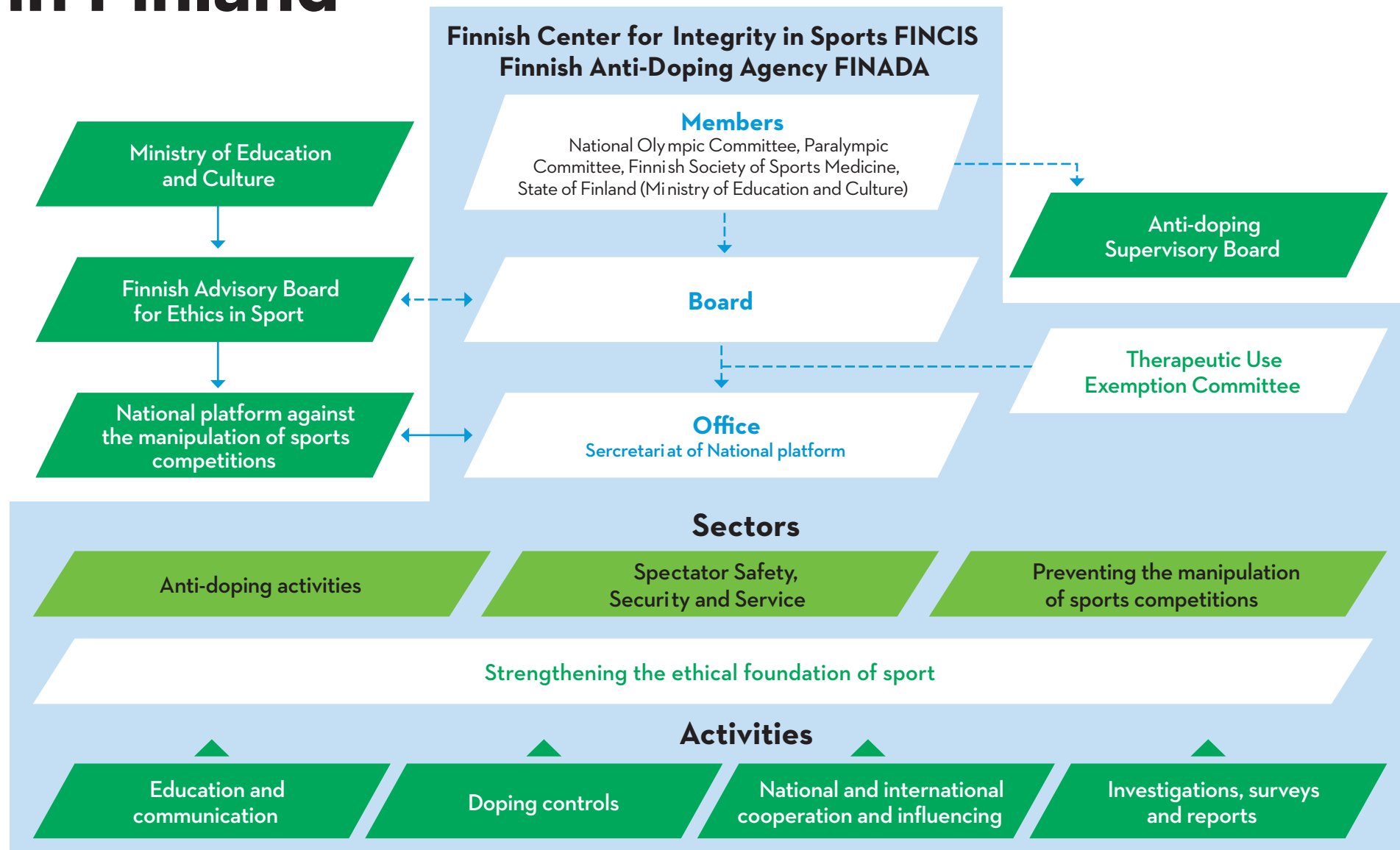
FINCIS is a non-profit organisation that receives its primary funding from the Ministry of Education and Culture's lottery funds and from its partners.
